

## WEBSITE USAGE PARENTAL CONSENT & RELEASE FORM

## **Notice to Parents/Legal Guardians:**

- 1. The Children's Online Privacy Protection Act (COPPA), (www.coppa.org), is a federal law intended to help parents/legal guardians remain in control of the personal information websites and other online services can collect from their children under 13 years of age. Although nonprofit organizations are exempt from COPPA, The Orchestra of Northern New York, a nonprofit, professional symphony orchestra incorporated in New York State, takes very seriously the privacy rights of children. Therefore, ONNY is complying voluntarily with the rules of COPPA by obtaining verifiable parental consent for the collection, use, or disclosure of a child's personal information on its website.
- 2. The Orchestra of Northern New York's (ONNY) privacy protection for children is incorporated in its website Privacy Policy <a href="https://www.onny.org/policy-privacy">www.onny.org/policy-privacy</a>.
- 3. ONNY's website allows users to upload personal content, such as photos/images, videos, audio recordings, and text, and to engage in live Zoom sessions for two of its ONNY ONLINE programs that may involve children under 13, namely, "Improv Sessions with ONNY Musicians" for students in Grades 5 12, and "Mini Music Lessons with ONNY Musicians." In delivering these programs, ONNY collects personal information from its users that may include: name, username, mailing and email addresses, school of attendance and grade, in addition to any of the personal content, such as photos and/or audio/video recordings, that your child may upload to ONNY's website.
- 4. We will not grant your child access to any ONNY website programs unless you provide us with permission in writing on the approved form below.
- You may revoke your consent at any time, refusing to allow further collection, use and/or disclosure of your child's personal information.
